### BULKY WASTE COLLECTION GUIDELINES PER WASTE MGMT

Bulky waste should be on the curb **no** earlier than Friday August 28th, and **no** later than 6:00 am Monday, August 31st. Items must be within 4 ft. of the curb. We cannot come onto your property to retrieve the bulky waste items. Items should be set at least 5 ft. from mailboxes, gas meters, cars, shrubs, or anything else that could interfere with our mechanical lifting arm. For the same reason, items should be set at least ten feet away from utility poles, to prevent contact with overhead power lines.

## We will pick up a maximum of 4 cubic yards of bulky waste.

CUBIC YARD IS: 1 YARD (DEEP) X 1 YARD (WIDE) X 1 YARD (HIGH) 1 YARD IS: 3 FEET OR 36 INCHES



#### What we **CAN** pick up:

Large and small household appliances (no appliances with Freon)

**Furniture** 

Carpets

Large cardboard boxes (broken down and tied into tight bundles)

Mattresses

Trees and limbs (4 ft. length bundles)

Fencing

Non-contracted remodeling waste (leftovers from do-it-yourself projects).

#### **Resolution 07-22-2020**

# A RESOLUTION DECLARING A STATE OF EMERGENCY FOR THE CITY OF SPENCER UNTIL AUGUST 31, 2020

- WHEREAS, Governor Stitt published Open Up and Recover Safely, a three-phase approach to open Oklahoma's economy, on April 22, 2020; and
- WHEREAS, based on scientific modeling from public health experts the three-phase approach is intended to mitigate the risk of resurgence, protect Oklahoma's most vulnerable citizens and is intended for businesses and individuals to utilize in conjunction with guidance from the OKC-County Health Department, the Oklahoma Department of Commerce, the Oklahoma Department of Health, and the Centers for Disease Control (CDC); and
- WHEREAS, the Secretary of Health and Mental Health will confirm prior to proceeding to a new phase that Oklahoma COVID-19 hospitalizations and incidents are at a manageable level, that hospitals are treating all patients without alternate care sites, that there is sufficient testing material in the state and ability to conduct contact tracing, and that the state can quickly and independently supply sufficient Personal Protective Equipment (PPE) and critical medical equipment to handle the surge.

# NOW THEREFORE, I, FRANK CALVIN, THE MAYOR OF THE CITY OF SPENCER, OKLAHOMA, DO HEREBY PROCLAIM AND DECLARE:

**SECTION 1:** A state of emergency exists within the corporate limits of the City of Spencer, Oklahoma County, Oklahoma pursuant to Title 63 O.S. §24-683.1 et al, the Oklahoma Emergency Act of 2003.

**SECTION 2:** This proclamation shall become effective immediately upon signature by the Mayor.

**SECTION 3:** The declaration of a state of emergency shall be extended through August 31, 2020.

**SECTION 4:** Facial masks shall be worn at all indoor venues, when out in public places and when unable to stay at least 6 feet away from others.

**SECTION 5:** The City of Spencer will continue to adhere to sanitation and physical distancing protocols and CDC-recommended guidelines from the Oklahoma Department of Commerce.

**SECTION 6:** For those over 65 or part of a vulnerable population, continue following physical distancing from others when in public and avoid socializing in groups or facilities that do not readily allow for appropriate physical distancing.
