## **BE "COURTEOUS AND RESPONSIBLE" ON THE 4<sup>TH</sup> OF JULY....**

On behalf of the Spencer Mayor and City Council please be courteous and responsible as we Celebrate our Nation's Independence Day. To assist, we have included the following tips, as well as the City of Spencer's Ordinance for your review:

**\*Section 26-182 Litter Not to Accumulate on Property**

**\*Section 1-108 The City's General Penalty Code (\$500) will be assessed to those that leave litter and debris behind.**

Kringlen Park will **"NOT"** be open on July 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> due to liability issues at the local park.

**Section 28-66 Fireworks Use Regulated:**

- No fireworks shall be discharged within 500 feet of where fireworks are stored, sold or offered for sale.
- Fireworks shall be discharged July 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup>, only between the hours of 8am and 12 Midnight.
- No fireworks shall be discharged within 500 feet of any church, hospital, asylum, public school, Flammable agricultural crop, or within 100 feet of other buildings or residences, except in those instances where the Fire Chief has issued a permit upon written request.
- No person shall ignite or discharge any fireworks within a motor vehicle or throw the same from a motor vehicle or at or near any person or group of persons.
- No person shall discharge any fireworks from across or onto a road, street, or public highway.
- No person shall discharge, ignite or assist in discharging or igniting fireworks of a type commonly known as “pop bottle rockets” or “stick rockets.”
- Pyrotechnical displays shall be approved by the Code Enforcement Officer and/or Fire Chief. The time, place, and manner of such displays must be approved.

**It is “NOT” the responsibility of the City of Spencer, Oklahoma to clean up the litter and debris left behind on July 3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> nor will we assign city personnel to clean up as we celebrate National Independence Day!**

**Remember...**with new COVID 19 infections peaking again in Oklahoma with triple digits confirmed in the State of Oklahoma, Mayor Calvin and the City Council strongly encourages Spencer residents to take precautions to protect themselves and follow the guidance of “Social Distancing and Masks!”

**Code Enforcement...**Notice to Property Owners! When mowing, please do not discharge grass cuttings on the streets of Spencer, Oklahoma! Fresh grass cuttings on our streets create a dangerous safety hazard for motorcycles, bicycles and other two-wheeled recreational vehicles.
