A RESOLUTION RELATING TO THE INCURRING OF INDEBTEDNESS BY THE TRUSTEES OF SPENCER UTILITIES AUTHORITY TO BE ACCOMPLISHED BY THE ISSUANCE OF REVENUE BONDS SERIES 2020 IN THE AGGREGATE PRINCIPAL AMOUNT OF NOT TO EXCEED \$8,850,000.00 TO PROVIDE A PORTION OF THE FUNDS REQUIRED TO REFUND OUTSTANDING INDEBTEDNESS AND OTHER OBLIGATIONS OF THE AUTHORITY AND THE CITY; AND TO PROVIDE CAPITAL IMPROVEMENTS FOR THE CITY AND THE AUTHORITY; AND DECLARING AN EMERGENCY

WHEREAS, the Spencer Utilities Authority, a public trust (the "Authority"), has been created by a Trust Indenture dated as of January 26, 1966, for the use and benefit of the City of Spencer, Oklahoma (the "City"), under authority of and pursuant to the provisions of Title 60, Oklahoma Statutes 2019 Supplement, Sections 176-180.3, inclusive, as amended and supplemented, the Oklahoma Trust Act and other applicable Statutes of the State of Oklahoma; and

WHEREAS, the Trustees of the Authority have determined upon a financing plan consisting of providing a portion of the funds required to refund and retire certain outstanding indebtedness and other obligations of the Authority and the City, and to provide capital improvements for the City and the Authority; and

WHEREAS, in order to effect the said financing, the Trustees of the Authority intend to incur indebtedness in the aggregate principal amount of not to exceed \$8,850,000.00, said indebtedness to be evidenced by the issuance of Revenue Bonds Series 2020 (the "Bonds") of the Authority, pursuant to the terms and conditions contained in a Revenue Bond Indenture securing the Bonds (the "Indenture");

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SPENCER, OKLAHOMA:

<u>SECTION 1.</u> The financing plan, as submitted, will refund and retire certain indebtedness and other obligations of the Authority and the City, and provide for capital improvements for the Authority and the City of Spencer, Oklahoma. The

aforesaid project will serve the public purposes of the City and hereby is expressly determined to be in furtherance of the public purposes for which the Authority was created.

SECTION 2. The incurring of indebtedness by the Trustees of the Spencer Utilities Authority in the aggregate principal amount of not to exceed \$8,850,000.00, in order to provide a portion of the funds required to retire certain outstanding indebtedness and other obligations of the Authority and the City, and provide capital improvements for the City and the Authority, is hereby consented to and approved by the City Council of the City of Spencer, Oklahoma, the governing body of said City. The sale of the Bonds at a discount of not to exceed One and eighty-five hundredths percent (1.85%) is hereby expressly approved and competitive bidding upon the Bonds evidencing said indebtedness hereby is expressly waived.

SECTION 3. By reason of the need to refund and retire certain outstanding indebtedness and other obligations of the Authority and the City, and to provide capital improvements for the City and the Authority and for the immediate preservation of the public peace, health and safety, an emergency hereby is declared to exist and this Resolution shall be effective immediately upon its adoption.

RESOLUTION NO. 05-21-2020

A RESOLUTION APPROPRIATING THE PROCEEDS OF A FOUR (4%) SALES TAX LEVIED BY THE CITY OF SPENCER, OKLAHOMA, TO THE TRUSTEES OF SPENCER UTILITIES AUTHORITY; AND DECLARING AN EMERGENCY

WHEREAS, heretofore, the qualified electors of the City of Spencer, Oklahoma, approved said City levying an excise tax of four percent (4%) upon the gross proceeds or gross receipts derived from sales taxable under the law of the State of Oklahoma; and

WHEREAS, the governing body of said City has determined that the proceeds of said levy will be used in a manner to enable the Spencer Utilities Authority to provide funds to refinance certain outstanding indebtedness of the Authority and to provide for capital improvements of the City and the Authority; and

WHEREAS, it is now deemed necessary to provide for the appropriation of said proceeds to said Trustees for the purposes aforesaid;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SPENCER, OKLAHOMA:

SECTION 1. It hereby is determined to be in the best interest of the City of Spencer, Oklahoma and its citizens, that the proceeds derived from the levy of the four percent (4%) sales tax approved by the electors of said City, be appropriated to the Trustees of the Spencer Utilities Authority to enable said Trustees to pay debt service on revenue bonds issued by the Authority to provide funds to refinance certain outstanding indebtedness of the Authority and to provide capital improvements of the City and the Authority, and all remaining funds not needed for such purposes shall be transferred by the Authority to the City.

SECTION 2. There hereby is appropriated all of the proceeds to be derived from the four percent (4%) sales tax levied and collected by the City to the Trustees of the Spencer Utilities Authority.

SECTION 3. The Mayor, City Clerk, and Treasurer are hereby authorized and directed, after having deposited the proceeds of the aforesaid four percent (4%) sales tax monthly, as received, in the General Fund of the City and after having paid the costs and expenses of collecting said tax, to forthwith pay all of said sum to the Trustees of the Spencer Utilities Authority and the Chairman, Secretary and Treasurer of the Spencer Utilities Authority are further directed to transfer any of the aforesaid sales tax proceeds not needed to pay debt service on the aforesaid indebtedness back to the General Fund of the City in due course unless otherwise prohibited by the laws of the State of Oklahoma. A certified copy of this Resolution shall be delivered to each of said officials and shall constitute their continuing authority to make such monthly deposits, transfers and payments hereinabove directed.
